Eligibility Criteria:

1. The Technical personnel appointed in ICAR against the entry level post of Driver/Technician T-1 in Category-1 of TSR and having five years of regular service in the Pay level-3 of VII CPC.
2. The employees should have completed five years of regular service as on the date of calling of applications 03-09-2024, except in case where the request is being made on medical/working spouse grounds, etc.
3. The terms and conditions for inter-institutional transfer will be governed as laid down in the Council's letter No. 19(01)/2002-Estt.IV dated 19-03-2020 & TS-19(6)/2020-Estt.IV dated 19-03-2021.
4. The applicant applying for Technician T-1 post (sr. no.1) should have 5 years of experience as electrician.
