
It is proposed to appoint a part time Doctor in the medical field of General Physician (Allopathy) for the medical consultation of ICAR staff and their family at Old Goa.

Applications in sealed cover are invited by the Director, ICAR-Central Coastal Agricultural Research Institute, Ela, Old Goa from the registered/Authorized Medical Attendant for medical consultation and treatment of about 90 ICAR staff and their family members at the following terms and conditions :-

- If the AMA's clinic is within 1 Km radius of this Institute, he/she will provide consultancy at his/her clinic to the staff members and their family. Preference will be accorded to the Institute staff in case of queue. The clinic must be open at least 5 days a week with consultation period not less than 2 hours per day within the office timing 10:00 AM to 5:00 PM.
- If the AMA's clinic is beyond 1 Km radius of this Institute, he/she will have to visit this Institute 3 days a week and provide consultancy for 2 hours per day within the office timing 10:00 AM to 5:00 PM. The Institute has a designated place for the AMA.
- In case of emergency, the AMA shall attend to the patient at this Institute or his clinic or his home as the circumstances demand even beyond the clinic/consultancy timings.
- Interested Registered/Authorized Medical Attendant should ensure that their applications reach this Institute latest by 15:00 hrs of 22.09.2017 in a closed envelope comprising the application letter, supporting documents for qualification and experience, MCI registration details and expected remuneration detail (to be valid from 01 Year) to the following address :-
