

The Tendering Firms (Tenderers/Contractors/Agency/Firms) are required to upload **scanned copies** of the following documents:-

● **TECHNICAL:**

- a) **Registration certificate** (valid) of the firm under the work contract of the Appropriate Authority [*Registration under SHOP AND ESTABLISHMENT ACT 1948/The Companies Act, 2013/or any other Act*].
- b) Copy of Valid **license** under the Private Security Agencies (Regulation) Act, 2005 from the appropriate authority of the State of Goa.
- c) Documentary evidence of last 3 years **experience** of the firm (in **Annexure III**) in the field of providing such services in Central Govt. establishments/Autonomous bodies of Govt. of India/ Corporations of Govt. of India/state govt. establishments/reputed public or private organizations. Last 3 years will be determined from 01.04.2017.
- d) Certificate issued by a Chartered Accountant endorsing the **annual turnover** of the firm for the last 2 Financial Years, i.e., 2018-19 & 2019-20. Minimum turnover of the firm should not be less than Rs. 1.00 Crore (Rupees One Crore only) per annum during each of the last two financial years.*
- e) **EPF** registration certificate.
- f) **ESI** registration certificate.
- g) Scanned copy of **EMD**/its exemption, if any.
- h) **GST** Registration Certificate
- i) Duly-signed Annexures – **II, VI & VII**
- j) Duly-filled Checklist as in **Annexure VIII** – Tenderers must ensure that all the above documents have been uploaded and clearly ticked on the checklist. Bids with any Un-ticked box in the checklist may be rejected. Hence, it is advised that only those firms should bid who have all the required documents. Further, any deviation between the checklist and the uploaded documents may lead to rejection of bids.

*** Micro & Small Enterprises, Firms having NSIC Certificate, Central Government and State Government Bodies, PSUs, DIPP-recognised Start-Ups are exempted from EMD, turnover and prior experience criteria. Necessary certificates must be uploaded on the e-portal to claim the exemptions.**
